RELEASE FROM LIABILITY AND AGREEMENT NOT TO SUE

PLEASE READ THIS CAREFULLY

In consideration of permission given me by the Battle Creek Hunt of Augusta, Michigan (herein called "the Hunt") to participate in any or all activities of the Hunt, I hereby acknowledge that my participation in any of said activities from time to time is undertaken with full knowledge and recognition of the inherent risk and dangers involved in such activities, as well as the fact that unanticipated and unexpected dangers may arise during said activities, and I hereby **ASSUME ALL RISK** of loss of life or injuries to my person and/or property that may be sustained in connection with any such activities.

I have inspected the facilities, premises and courses of the Hunt as well as all land utilized by it in the hunt and other activities, and I hereby, for myself, my heirs, administrators and assigns, **RELEASE AND DISCHARGE** the Hunt and each and everyone of its members, servants, agents, officers, stockholders, directors, officials and employees, and all other participants in the activities of the Hunt, including landowners, of and from all claims, demands, actions and causes of action of any sort, that may arise during my presence in or on the said facilities, premises, courses and lands or that may arise out of my participation in the activities of the Hunt, and/or my use of the said facilities, premises, courses and lands, whether due to negligence or otherwise and hereby further covenant and agree to **NEVER BRING SUIT** against any of the aforementioned parties for any injury to my person or property so arising.

In consideration of my child's (children's) participation in any of said activities, we, our heirs, administrators and assigns, **RELEASE AND DISCHARGE** the Hunt and each and everyone of its members, servants, agents, officers, stockholders, directors, officials and employees and all other participants in the activities of the Hunt, including landowners, of and from any and all claims, demands, actions, and causes of action arising during my child's (children's) presence in or on the said facilities, premises, courses and lands, or that may arise out of my child's (children's) participation in the activities of the Hunt and/or my child's (children's) use of the said facilities, premises, courses and lands, whether due to negligence or otherwise and hereby further covenant and agree to **NEVER BRING SUIT** against any of the aforementioned parties for any injury to my child (children) so arising.

I do further authorize any officer, director, or supervisory personnel of the Hunt and of the various activities thereof, to consent in my behalf to any emergency medical treatment by a properly licensed person, which may be required for my child (children), and do agree to indemnify and hold harmless anyone giving such consent.

I further certify that my attendance or participation, as well as my child's (children's) attendance or participation is any of the aforesaid activities is voluntary.

I understand that horseback riding and riding to hounds will expose me and my child (children) to **ABOVE NORMAL RISKS**. These risks include loss of control, collision, obstacles, variation in terrain, and unexpected action of the horses.

I represent that my child (children) and I have no health or physical problems that will interfere with horseback riding.

I agree that I am responsible for my own safety and that of my child (children).

I agree to **ASSUME and ACCEPT** the dangers that inhere to the activity of horseback riding and riding to hounds for myself and my child (children).

I HAVE READ AND I UNDERSTAND THE FOREGOING RELEASE AND AGREEMENT NOT TO SUE, AND I WISH TO SUBSCRIBE TO SAME.
